MINUTES OF THE JULY 15, 2009 TRC MEETING

The minutes of the April 8, 2009 meeting were approved. They will be entered into the Administrative Record for Navy Lakehurst located at the Ocean County Library in Toms River, NJ.

The status of groundwater treatment in Areas A, B, C, and H was presented and discussed. Semi-annual progress reports were provided to the regulatory agencies. Influent and effluent results from the Area A and B treatment system were discussed. The system influent and effluent results from the Area A and B treatment system have been non-detect since November 2007 and levels above 1 ug/l have not been detected in system influent since March 2007. Discontinuation of groundwater treatment in this area was proposed by the Navy.

A sparge/vapor extraction system was recently installed in area A-west to remediate the elevated levels of chlorinated volatile organic compounds in groundwater in the vicinity of monitoring well CF. This system will begin operation upon receipt of the air permit from the NJDEP.

The groundwater monitoring results from Areas D, I, J, and K were presented. The results show a decreasing trend in groundwater contaminant levels in these areas. In Area D, 14 of 23 wells were non-detect for volatile organic compounds (VOCs). Only three wells (DU, HP and IF) had VOC levels above 10 ug/l. In Areas I and J, 16 of 55 wells were non-detect for VOCs. VOC levels decreased in 33 wells during this sampling round. In Area K, 15 of 22 wells were non-detect for VOCs. Thew VOC levels in all other wells in this area were below 8 ug/l.

Building 266, a former dry-cleaning facility, was demolished in March 2009. The preliminary results of a soil boring investigation conducted at the site indicate elevated levels of tetrachloroethene in shallow soil samples. Additional soil samples will be taken to identify the extent of contamination.

A soil boring investigation will be conducted next month at Site 32 to identify the nature and extent of soil contamination that may be acting as the source of groundwater contamination in this area.

In accordance with N.J.A.C. 7:26E-1.4 Notification and Public Outreach, Navy Lakehurst has posted signs along the facility boundary indicating that "Environmental Investigation/Cleanup is in Progress at this Site". The signs also provide both Navy and NJDEP contact number for further information. A leter was also mailed to interested parties to notify them of the signs, provide information on the site, and identify any sensitive populations or resources in the vicinity of the site.

A team tasked by the Air Force to optimize the remaining sites at Navy Lakehurst visited the facility last month for a site tour and data collection. The team will return the last week of July to finalize their findings and present their recommendations to the Navy.

Navy Lakehurst continues to partner with Ocean County to preserve property surrounding the facility and ensure compatible land development.

The next TRC meeting is scheduled for January 13, 2009 in Conference Room #2, Bldg. 5 at 10:00 a.m.
