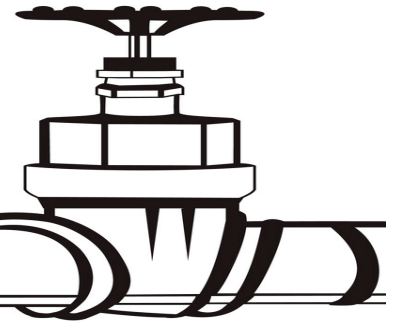


The New Jersey Pinelands Commission: must vote “NO” on the South Jersey Gas Pipeline through the Pinelands



South Jersey Gas, a private for profit entity, is asking the N.J. Pinelands Commission (the State agency that regulates the Pinelands area) for a special exception to the rules that protect the Pinelands, so that it can run 22 miles of pipe from one end of the Pinelands to the other.

The 24-inch diameter, high-pressure pipeline would go through some of the most pristine areas of Pinelands from Maurice River Township to the B.L. England power plant at Beesleys Point in Atlantic County. There will be huge amounts of land disturbance associated with the installation of this pipeline.

The proposed route through the Forest Management Area (environmentally sensitive management area) is a clear violation of Pinelands regulations.

Why the Commission must say NO:

- **The Commission has a statutory mandate** to protect the Pinelands and this type of project is forbidden in Pinelands Forest Management Areas by the Comprehensive Management Plan.
- There are alternatives to the proposed pipeline route that avoid running the pipeline through the Pinelands Forest Management Area.
- **South Jersey Gas had 30 years to plan future projects.** The regulations that protect the Pinelands have existed since 1982 – South Jersey Gas has had plenty of time to plan for the future.
- **It sets a bad precedent.** How will the Pinelands Commission be able to say “no” to future projects like this if it allows this project to go through?
