If you have not heard, Fred Ackers presented his alternate route to the Commissioners during public comment at the Commission meeting today. That route, along Route 50, is gaining momentum with many Commissioners as an alternative to Route A, especially given its location at the edge of the Forest Area and at the border of the Pinelands Area and the PNR. Absent a very compelling reason as to why this alternative is not feasible, I think it will be very difficult to convince the Commission that Route A is the only or best alternative.

With regard to the Conectiv offset methodology, as far as I know, there is no documentation in a file to provide to you. The prior Executive Director negotiated the offset directly. I had no involvement. I have asked Larry Liggett to attend the meeting on Tuesday given he was involved in developing the methodology. That is the best I can do. However, the information that I provided in the note to the offset outline sums up the methodology; there really isn't much more information to provide.

Finally, we have set aside time starting at 2:00 p.m. on Tuesday to meet to discuss the responses to the questions raised at the September P&I meeting, the Route 50 alternative and the offset outline. We would appreciate receiving your written responses by email given that Monday is a State Holiday and Nancy and I will need to retrieve this information remotely.
