### Pass the NJ Endangered & Threatened Plant Protection Act

New Jersey has over 2,100 species of native plants. This impressive diversity equates to approximately 13% of the floral diversity in the United States on just 0.25% of the landmass. New Jersey's plant diversity is largely attributed to the distinct ecological regions found here and that New Jersey is a meeting ground for both northern and southern species that are at the edge of their range.

Unfortunately, many of these species are rare in the state and we risk losing them from our natural heritage. A staggering 39% of native plants in New Jersey are considered rare and the overall trend is negative. From 2006 to 2016 the number of state endangered plants that were listed increased by 26 and the number of extirpated, or locally extinct, went up by 10 species. Beyond rarity at the state level, New Jersey is home to 42 species that are considered globally rare.

The Natural Heritage Program is a state program that is tasked with tracking the occurrences of rare plant species and their trends along with identifying the major threats to our rare species. Habitat loss due to development and urbanization has been, and continues to be, the greatest threat to our native plant species. Climate change, invasive species and changes to fire regime and hydrology are additional major threats to our rare plants. These stressors to plant populations are particularly worrisome given that 60% of our endangered plant species occur only on private lands.

Even though New Jersey has a list of rare and endangered plant species, these plants are not yet protected by state law. Plant protections in the state are limited to regional agencies or rules like those found in the Pinelands, Highlands and Coastal areas. These rules are limited to specific regions and often they do not offer protections to all rare plants in the region.

The Pinelands Comprehensive Management Plan (CMP), for example, offers protection to state endangered plants and 54 plant species that were listed in the original drafting of the CMP. This leaves

No noisy car campsites line our rivers and limited automobile access contributes to the peace and serenity you'll experience while on a Pinelands Adventures expedition.

### Pinelands Preservation Alliance Welcomes New Staff

We have some new people joining our team this year! In January, Jeff Tober was hired as our first Farm Manager and Andrew Gold joined PPA as Legal Director in March.

### Farm Manager – Jeff Tober



Last July PPA received an extraordinary donation of farmland adjoining its head-quarters. Cindy Yingling, Louis Eni and Chris Eni inherited the 72-acre farm from their aunt and uncle, Lore and George Giacchino. Cindy, Louis and Chris are proud multi generation residents of Burlington County. This gift reunites land that had once formed part of a large farm first established by Quaker settlers in 1704.

This farm is in the Farmland Preservation Program and PPA will be using this land to promote sustainable farming and land management. Jeff was hired as Farm Manager to create and manage a new sustainable farming operation on the 72-acre property. He will work to produce great food, build soil health, plant a diversity of annual and perennial crops and work to attract native pollinators and birds.

Prior to joining the PPA staff, Jeff started a CSA farm (Community Supported Agriculture) at Fernbrook Farms in Chesterfield in 2007 and was the Farm Manager for 13 years. Jeff got his love for growing food at Aspen Farms Community Garden in West Philadelphia and later apprenticed at Brookfield Farm CSA in Amherst, MA.

Jeff got his degree in English from Muhlenberg College and later served for two years with AmeriCorps. He went on to work for the Pennsylvania Horticultural Society's Philadelphia Green Program revitalizing urban parks before farming full-time. Jeff is on the board of the New Jersey Agricultural Society and the Burlington County Agricultural Development Board.

Jeff said, "I have always been very impressed by PPA, their tremendous staff and the great work they do. So when I saw they were looking for a Farm Manager for this new project, I was really excited. Leaving Fernbrook was not easy but this new opportunity is ripe with challenges and great possibilities. I look forward to helping PPA establish a productive, diverse, sustainable and beautiful farm!"

PPA's goals for the farm include (1) create a vegetable and fruit farm guided by organic growing and sustainable soil and water management principles; (2) carry out a soil and stormwater management plan which prevents or minimizes runoff and soil loss into Vincentown and the Rancocas Creek system; (3) promote sustainable farming, human health and habitat stewardship through a range of public outreach and education programs and (4) expand the community of people who know about and support PPA's work.

### Legal Director - Andrew Gold



Andrew is PPA's in-house attorney and advocate on policy, regulatory and development matters affecting the New Jersey Pinelands. The attorney position is needed to ensure PPA has the staff capacity to be effective in its issue advocacy and litigation projects.

After graduating from law school in 2014, Andrew worked for the United Food and Commercial Workers, Local 1776KS, one of the largest labor unions in the region. As an in-house attorney with the Local, he handled day-to-day legal issues that arose, negotiated contracts, supported outside counsel in litigation, and oversaw regulatory compliance for the union, particularly with respect to campaign finance and lobbying disclosure. Among other projects, he helped lead the organization of workers in the medical marijuana industry and negotiated the first-ever collective bargaining agreements for cannabis workers Pennsylvania.

Andrew said, "Part of my dedication to the labor movement is the idea that everyone should have the ability to live fulfilling and rewarding lives. By shifting power to working people, strong unions help people live better by freeing up time otherwise spent chasing after every dollar to make ends meet. Among other things, I happen to think that open space and opportunities to be outdoors are essential components of 'the good life,' and protecting the natural environment is a key part of promoting public health."

Andrew continues, "To me environmentalism is a cause that is relevant right in our own backyards in every community. That is especially so in densely populated New Jersey, where we have a remarkably large area of protected space surrounded by development. When I learned that there was a job opening at the Pinelands Preservation Alliance, I jumped at the opportunity to help protect this beautiful place in my home state. Growing up around the Pine Barrens and knowing that wilderness was a short drive away from suburbia, I know the value of this unique place."

### Update: Nominations to the Pinelands Commission

Governor Murphy nominated four new people to the Pinelands Commission in 2019, Theresa Lettman, Jennifer Coffey, Jessica Rittler Sanchez, and Robert Jackson (a former Pinelands Commissioner) and re-nominated an existing Commissioner, Edward Lloyd. Unfortunately, an entire year went by and the Senate failed to confirm these appointments. Now the process must start all over again.

Hopefully by the time you read this article, the Governor will have nominated this list of individuals again. The Senate Judiciary Committee and the full Senate must approve the Governor's nominations to the Pinelands Commission before they can serve.

The Senate Judiciary Committee is chaired by Nicholas Scutari (D-22), and the vice-chair is Nellie Pou (D-35). The chair is responsible for convening the Committee and placing individuals and items on the agenda with consent by the Senate President, Steve Sweeney (D-3).

Pinelands Commission appointments aren't the only ones on hold in the state. The Highlands Council, Delaware & Raritan Greenway, the Water Supply Advisory Council and others are in similar situations with appointments pending before the Senate. The Pinelands Commission may be in more dire straits however. There are two vacant seats on the Commission and three members are missing meetings regularly. As a the Commission has struggled to achieve quorum for (they meetings need affirmative votes to pass anything) which has stymied action on important issues like rule changes on water protection.

The most notable of the missing

Commissioners is Candance McKee Ashmun. Candy is the last original member of the Pinelands Commission and she just turned 96! Ms. Ashmun has served since the Commission was founded more than forty years ago in 1979. Theresa Lettman, who retired from Pinelands Preservation Alliance after a very successful 26-year career, was nominated to fill Candace Ashmun's seat. In fact, Candy requested Theresa as her replacement. Ms. Ashmun's seat should be filled immediately, so she can depart knowing that the Commission is still functional.

#### What can we do?

Staff from the Pinelands Preservation Alliance are meeting with legislators and government officials to discuss the situation, but we need your help. It is critical that your Senator understands how important it is to have the seats filled on the Pinelands Commission by a diverse team who support the Pinelands Protection Act and the Comprehensive Management Plan.

### **Endangered and Threatened Plant Protection Act**

55 rare plant species that are known to exist in the Pinelands without any protection.

Most people do not know that unlike animals, rare plants do not have any statewide protections and do not have a recognized threatened category. In 1973, New Jersey signed into law the New Jersey Endangered Species Conservation Act, which established laws to protect and restore endangered and threatened wildlife in the state. This legislation led to the creation of the Endangered and Nongame Species Program to do the work necessary to protect the state's rare wildlife.

Currently, 35 wildlife species are listed as endangered and 25 are threatened. The Endangered Species Conservation Act has protected our wildlife from capture, kill, harassment, habitat destruction, over-exploitation, and pollution for close to 40 years. It's about time we protect our botanical heritage as well. Plant and animal communities are inextricably intertwined. Our plants and plant communities are the sole source of food and habitat for wildlife and cannot be neglected if we are to truly protect our wildlife.

Assemblymen Herb Conaway and Kevin Rooney have teamed up to co-sponsor bill A985, the New Jersey Endangered and Threatened Plant Protection Act, which will offer protection to New Jersey's rare plant species.

This legislation would protect known populations of rare plants from intentional damage and sale or transport with some specific exceptions. The bill will also establish a threatened category for plants. This ensures that our recognition and characterization of rare species uses language that is consistent with other states and the federal government. Lastly, this bill directs the commissioner of the Department of Environmental Protection (DEP) to

establish an "Endangered and Threatened Plant Species Advisory Committee". This committee would be tasked with developing conservation plans for priority rare species, which will ensure that the DEP is not only protecting the rare plants we know of, but actively working to increase the number of individuals with the ultimate goal of delisting species if appropriate.

There have been calls for rare plant protection legislation for decades. Now is the time to take action. This bill was first introduced in 2019 and needs support from the public to move through our legislature. This bill has recently been referred to the Assembly Agriculture Committee.

Contact the members of this committee and let them know you want to see this bill passed through committee. Let your senator know you want to see a senate version of this important legislation.

We need to move away from documenting the decline of our New Jersey native plants and being implementing the measures that will protect our remaining wild plant populations. The longer we wait, the more difficult it will be to protect what we have left.
