Pinelands Commission Nominations Stalled

Sometimes progress is so painfully slow, the temptation to throw your hands up in defeat feels overwhelming. You may feel this way about the stalled nominees to the Pinelands Commission. If you do, we understand.

For those who haven't followed this twoyear long saga, here's a little background. The Pinelands Commission is the critical state agency charged with overseeing land use, natural resource protection and implementing the Comprehensive Management Plan (CMP) within the Pinelands National Reserve. A board of fifteen Commissioners heads up the agency: seven gubernatorial appointees, one federal appointee, and one appointee from each of the seven Pinelands counties.

In 2019, Governor Murphy nominated four highly qualified candidates to serve, and re-nominated Commissioner Ed Lloyd. All five candidates, including Theresa Lettman, Bob Jackson, Jessica Rittler-Sanchez and Jenn Coffey, needed a vote in Senate Judiciary Committee

prior to advancing to the full Senate. However, months passed without any of the nominees making it on to the Judiciary agenda. The reasons vary, but the result for all five was the same; the legislative session ended in January 2020, and the process started over.

Fortunately, the Governor made the same nominations again in early 2020, but history repeated itself. To date, none of the candidates have advanced in the Senate.

Meanwhile, the Pinelands Commission is currently operating with three vacant seats. A number of current Commissioners have made clear their desire to step down, or their disinterest in attending meetings. As a result, the bare minimum for a quorum (eight Commissioners) has been the normal attendance month after month.

This slate of Commissioners has failed to take real action on off-road vehicle damage, protecting water supplies in the face of climate change, and other

Getting outdoors in nature is good for our health and well-being. Studies have shown that if people feel safe, time in nature can lower blood pressure, stress hormones, and improve mood among many other benefits.

Despite being the most crowded state in the nation, New Jersey has a large amount of open space, including the 1.1-million-acre Pinelands National Reserve. The forests, streams and ponds found here are an important resource for residents in the region.

Unfortunately access to the vast natural areas found in the New Jersey Pinelands can be difficult if not impossible for people with physical or other disabilities. Visiting natural places can be uncomfortable, unsafe or impossible. Barriers may include a limited number of accessible sites or a lack of comprehensive and reliable information of the accessible sites that do exist.

The Pinelands Preservation Alliance wants to help overcome these barriers so everyone can enjoy the benefits of time in nature and visit the parks, forests and preserves which our state and communities have protected.

We are collaborating with two extraordinary partner organizations, Disability Rights New Jersey and Hopeworks. Together, we will work with the disability community to make the Pinelands more accessible to everyone.

We will engage with individuals, government agencies and other non-profits to listen and learn from people with disabilities about the obstacles they find in enjoying the Pinelands' natural places.

We will create a unified hub of online, mobile-friendly information about existing facilities and opportunities. We will identify the improvements and new facilities that are needed and propose specific new projects in underserved communities.

We will establish an ongoing forum for sharing insights, ideas and information about nature accessibility. This will keep accessibility on the agenda for public and private land managers who care for our natural public spaces.

This initiative is funded by an Inclusive Healthy Communities Grant from the Division of Disability Services, New Jersey Department of Human Services. This is a new state program that is funding great work around New Jersey to help people with disabilities improve their health and quality of life.

Director of Conservation Science Carlos Martínez Rivera

I am from the island of Puerto Rico, where I completed my BSc in biology with

a minor in botany at the University of Puerto Rico-Mayagüez in 2001. I obtained my doctoral degree from the University of Missouri-Columbia in 2008. The focus of my dissertation was to understand how sexual selection shapes the evolution of frog calling behavior and male-male interactions in noisy, competitive environments (frog choruses), and how females select individual mates from the chaos of the chorus.

During my graduate career I worked with Reserva Ecológica Comuna Loma Alta in Ecuador helping them protect one of the few remaining tracts of coastal cloud forests and dry forests in the region, a unique and fragile habitat home to many Critically Endangered animals and plants.

In July 2008 I became Curator of Amphibians and Reptiles and Amphibian Conservation Biologist at the Philadelphia Zoo, and developed holistic Amphibian Conservation Programs for critically endangered amphibians in the Tropical Andes and the Caribbean through ex situ (captive breeding) and in situ (on site) conservation, as well as policymaking and advocacy. In Philadelphia, I helped establish empathy-building programs with animals where children learn prosocial skills and develop empathy towards wildlife. We carried out citizen science initiatives through our local FrogWatch® chapter and by helping environmental groups in the region.

I am thrilled to join the PPA as Director of Conservation Science, where I hope to be able to combine science data with policy making and outreach programs to effect real conservation actions at the state, regional, and local level in New Jersey. The Pine Barrens region is a unique habitat that deserves immediate protection. By joining the awesome team at PPA I can continue to carry out conservation projects and actions that translate to meaningful and beneficial impacts to the local wildlife and habitats around us.

Land, Trails and the 30 x 30 Plan

The federal government has recently set a goal to preserve 30% of the country's land and waters by 2030 to protect biodiversity and natural resources. Reaching this goal will help mitigate the impact of climate change, preserve nature, and ensure access to clean water, clean air, and outdoor spaces for all communities.

While New Jersey is small compared to California or Alaska, our population density makes each acre of land extremely valuable. Luckily, New Jersey is well ahead of the country's new minimum standard because of the hard work and foresight of citizens and government officials over the last century. The seven counties within the Pinelands contain over 50% of the state's total open space holdings at 691,925 acres preserved with the vast majority of that acreage falling within Pinelands boundaries.

In total, the state has preserved 34% of its land area including 1,355,035 acres in open space and another 230,040 acres in farmland preservation as of 2018. But the rate of development in some Pinelands counties is among the highest in New Jersey. This means the race is on to preserve land. PPA plays a role in this effort by discussing the prospects of public acquisition with large landowners and the New Jersey Green Acres program, purchasing some parcels in fee ourselves, and working with partners like the Rancocas Conservancy, and the New Jersey Conservation Foundation to further their mission.

While the acquisition of lands for the public trust continues to be successful, there remain challenges in the management of preserved lands. Specifically, as land has been preserved, the budget for managing these areas has not risen in

proportion to the acreage. Most state agencies face the lowest staffing levels of any year in this century, making the management and stewardship of lands even more difficult. For example, New Jersey Natural Lands Trust, which holds and manages 26,000 acres statewide, has only one field employee. Both NJ Parks & Forests and NJ Fish & Wildlife have critical maintenance positions yet to be filled. In the coming months, PPA and our partners will advocate for agency budget increases. Volunteers can help in the interim. We continue to organize volunteer projects to protect habitat from off-road vehicles, to clean up, and if possible prevent, illegal dumping, and to create and maintain hiking and multi-use trails.

Recently, we partnered with NJ Parks & Forests to create the Tulpehocken Connector Trail, an 18.1-mile route that starts at the Batona Trail at Penn Swamp in Wharton State Forest reconnects to it at Apple Pie Hill. When finished this trail will link Penn Swamp, Jemima Mount, the Tulpehocken Lowlands, Hawkings Bridge Campsite, the area of Friendship and its old cranberry bogs, Sandy Ridge, and Ore Spung, giving hikers the chance to see some unique locations in the Pines.

Additionally, we are working with the Rancocas Conservancy to create a 3.1-mile trail at the Bucks Cove Run Preserve. This loop trail will start from the Whitesbog Village Parking area and traverse the 212-acre Bucks Cove Run Preserve, an inholding of Brendan T. Byrne State Forest. Nearby, the Rancocas Conservancy is working on another two-plus mile trail at the North Branch Preserve, along the North

Branch of the Rancocas Creek at Sunbury Village on Browns Mills Road in Pemberton Township. We are also working with the Crossly Preserve Alliance and the NJ Natural Lands Trust to rehabilitate and expand an existing trail at the Crossley Preserve in Tom's River. This trail links Whiting Wildlife Management Area and Manchester Wildlife Management Area on the New Jersey State Long Trail, a 380mile trail that PPA and volunteers have helped blaze throughout the Pinelands. The NJ State Long trail will extend from High Point State Park in the north to Cape May Point in the south. This trail highlights and connects many of the beautiful spots in New Jersey.

The more people enjoy sustainable recreation in the Pinelands the stronger the case for preservation and stewardship. Our government officials must prioritize funding for preservation and proper management of our public lands.

important issues. Without the addition of the experienced conservationists who have been nominated, the Commission is unlikely to take the bold action needed to protect the Pinelands against increasing development pressure.

One recent bright spot was the appointment of Burlington County's representative to the County Commission. The Commissioners have appointed Shannon Higgenbotham, the owner of a local family-run, sustainable farm and popular produce market in Evesham. She will bring her unique experience in environmentally-conscious management of farmland to productive Commission. She has also agreed to serve on the Commission's Climate Committee.

Back in Trenton, the confirmations seem stuck. The Judiciary agenda is set by Chairman Senator Scutari, as well as Senate President Sweeney. Despite thousands of phone calls and emails from New Jersey residents and Pinelands enthusiasts, neither Senator has budged. Many of the Governor's nominees to other boards have been confirmed, so this seems to be a specific Pinelands issue.

It is time for Governor Murphy to step up and push for his nominees. And we must step up and push the Governor. In this election year, he needs to hear just how much the Pines mean to us. He needs to know that there is no more time to waste on essential actions where the Commission has failed to act. He must use the power of his office to move these confirmations because of what it will mean for the Pinelands. Commissioners with demonstrated dedication to science-based solutions, and to conservation of precious ecological resources. It will mean Commissioners with fidelity

to the mission of the Pinelands Commission: to preserve, protect, and enhance the natural and cultural resources of the Pinelands National Reserve.

Instead of throwing your hands up, dig your heels in! It will take all of us to get this process moving and ensure we have a strong Pinelands Commission.

News and Updates from the Rancocas Creek Farm

Hello and greetings from Rancocas Creek Farm. It is spring and the farming season has begun. Our winter was busy and productive! In March we had a well drilled, completed our high tunnel construction, installed a walk-in cooler, added Asian Pear trees to our orchard, and made tons of rich, fertile compost. We also purchased a used cultivating tractor (from Kentucky no less - a stylin' International 274 circa 1984) and a used Chevy pick-up truck. And we are about to install a deer fence. The latter will encompass about a third of the farm's 72 total acres. Deer damage in this part of the world can be ruinous. Crops such as lettuce, beets, sweet potatoes, carrots, melons and winter squash are among the crops that stand little chance of surviving deer munching; I have experienced this level of crop destruction first-hand. So, we are taking advantage of a state program that helps farms fund the construction of deer fencing. Since we don't have a greenhouse yet, we have been using space at Walking Bird Farm in Galloway where our friends Jen and Ryan LaMonaca manage a farm. We started onions, parsley, scallions and cabbage toward the end of February and since then we have been filling the house with all sorts of veggies, flowers and herbs. It is great hang out and see their beautiful farm.

2021 is year two of Rancocas Creek Farm. Our focus on capital improvements, equipment purchases, infrastructure updates; soil building and perennial plantings are all designed to set the farm up for long-term success and sustainability. We are also working to develop the farm as a healthy ecosystem. My farming experience over the past 20 years has led me to believe that growing food for people does not have to be mutually exclusive from creating a diverse natural landscape. I would

argue the opposite, that a healthy, diverse farmscape enhances food production. We envision a farm rich in bird and insect life, perennials and annuals in flower all season long to support our native pollinators, and soils enriched by short term and multi season cover crops, compost applications, and mulches. The native trees we planted with funding from the Watershed Institute in 2020 in the farm's wet areas will act as a wind break and provide shade and permanent roots to reduce erosion and add habitat for the prementioned birds and pollinators. We will raise some pastured heritage breed pork this year. Livestock can be managed on a rotational basis to build soil fertility while producing food and farm income.

On the business side we are excited to launch our Community Supported Agriculture (CSA) this year and we are over halfway to achieving our goal for 2021 shares. We are also looking forward to growing food for weddings and events at PPA through our partnership with Jeffrey Miller Catering who is thrilled to be using fresh, chemical-free produce from our farm in their dishes. On the people side we are pleased to be hosting several part-time farmers and two Summer Interns, Katie Green and Alex Robb.

With all this work, I was very excited to be able to hire our new Assistant Manager Jess Brandeisky. I worked with Jess at Fernbrook Farm for many years and considered myself lucky to hire her this winter. Jess became interested in sustainable agriculture while she was studying Biology at Ramapo College, especially during a Study Abroad program to South India. While there, she saw how agriculture directly relates to social and economic rights, environmental justice, and community health. From that point Jess couldn't stop thinking

about our global food systems and their impacts. After graduating from Ramapo College in 2011 with a degree in Biology, she started working in a biotechnology lab. During this time she discovered Fernbrook Farms and began volunteering in 2014. She quickly realized that she was itching to leave the lab and get to the farm as often as possible so in 2015, she joined full-time Fernbrook's farmer apprentice program. Jess worked with me at Fernbrook from 2015 to 2020, gaining more responsibility each year and eventually working as Assistant Farm Manager for the final three years. After managing Fernbrook's CSA in 2020, Jess decided to make change and come work at Rancocas Creek Farm. She is thrilled to be farming in a way that helps further PPA's focus on community engagement and environmental protection. She is very excited to bring her enthusiasm for farming to PPA and to help in regenerating the farm's soil, increasing its biodiversity, and growing delicious food for local folks!
